LIABILITY RELEASE

Witness this release dated above by and between Crossroads Ranch INC., an Indiana for-profit business, (hereinafter referred to as "Management"), the operator of the stables, riding arena and real estate located at 6740 McFarren Rd, Gosport, IN 47433 (hereinafter, collectively, the "Ranch"), the property owner Tamra Ranard (hereinafter, collectively, the "Property Owner") and the (participant's name) _____, (hereinafter referred to as "Client"). For valuable consideration received, and in exchange for the covenants and representations herein made, Management, on behalf of itself, its facilitators, employees, and/or volunteers (collectively hereinafter referred to as "Crossroads Ranch") and client hereby agree as follows:

1. THE CLIENT AGREES TO ASSUME ANY AND ALL RISKS INVOLVED IN OR ARISING FROM OR RELATED TO CLIENT'S USE OF THE RANCH OR PRESENCE UPON THE RANCH, USE OF HORSES AND EQUIPMENT PROVIDED BY CROSSROADS RANCH WHETHER ON OR OFF OF THE RIDING FACILITIES, AND ANY RELATED APPURTENANCES, FACILITIES OR EQUIPMENT LOCATED THEREON, INCLUDING, BUT NOT LIMITED TO THOSE RISKS WHICH MAY ARISE FROM OR IN CONNECTION WITH THE NEGLIGENCE OF CROSSROADS RANCH. CLIENT ACKNOWLEDGES THAT THESE RISKS INCLUDE, BUT ARE NOT LIMITED TO, DEATH, BODILY INJURY OR PROPERTY DAMAGE DUE TO FALLS, KICKS, BITES, COLLISIONS, BEHAVIOR OF OTHER HORSES, FIRE, EXPLOSION, AND LIMITED EMERGENCY MEDICAL CARE AVAILABILITY.
2. Client acknowledges that horses, by their very nature are unpredictable and may act upon instinct, fright or whim. Client assumes all risks in connection therewith and expressly waives any claims for any injury, damage or loss arising therefrom. Client agrees to abide by and follow Crossroads Ranches' instructions, rules and regulations. Client further acknowledges that the behavior of any animal is contingent to some extent upon the ability of the client. Client assumes all risks therefore and warrants a full and fair disclosure of client's abilities have been made to Management. Client affirms that client has been well advised and thoroughly informed of the risks and inherent dangers of horseback riding and being in the presence of horses in general. Client agrees to assume any and all risks involved in or arising out of client's use of any equipment or livestock pertaining to the rental and riding of horses or riding lessons, the use of any equipment, arena or other structure on or about the Ranch, the use of any trail on or about the Ranch or related to any and all riding lessons whether provided at the Ranch or off of the Ranch.
3. CLIENT AGREES TO RELEASE, DISCHARGE, HOLD HARMLESS, INDEMNIFY AND DEFEND CROSSROADS RANCH AND THE PROPERTY OWNER FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION, DAMAGES, JUDGMENTS, ORDERS, COSTS OR EXPENSES, INCLUDING REASONABLE ATTORNEY'S FEES, WHICH MAY IN ANY WAY ARISE FROM OR BE IN ANY WAY CONNECTED WITH CLIENT'S USE OF OR PRESENCE UPON THE RANCH OR USE OF HORSES AND EQUIPMENT PROVIDED BY CROSSROADS RANCH WHETHER ON OR OFF OF THE RANCH, WHETHER OR NOT ARISING FROM THE NEGLIGENCE OF CROSSROADS RANCH OR ANY THIRD PARTY.
4. CLIENT HAS CAREFULLY READ AND UNDERSTANDS THIS CONTRACT AND AGREES WITH ITS CONTENTS. UNDER INDIANA LAW, AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO, OR THE DEATH OF, A CLIENT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.
